INTRODUCTION


- A. The Assignor is the registered proprietor of the trade marks (including the registrations and applications for those trade marks) set out in the Appendix (**Trade Marks**).

The parties irrevocably waive any objections to New Zealand as the forum for proceedings on the grounds of forum non-conveniens or any similar grounds.


