**TRADEMARK ASSIGNMENT**

This TRADEMARK ASSIGNMENT (this "Assignment"), made, executed and delivered as of December 18, 2014, by POHLMAN REPORTING COMPANY, a Missouri corporation, and POHLMAN DOCUMENT SERVICES, LLC, a Missouri limited liability company (together with Pohlman Reporting Company, the "Sellers" and each individually, a "Seller"), in favor of PRC PURCHASER LLC, a Delaware limited liability company (the "Purchaser").

**RECITALS:**

WHEREAS, the Purchaser, the Sellers and Victoria L. Pohlman are entering into an Asset Purchase Agreement contemporaneously herewith (the "Purchase Agreement"), pursuant to which the Purchaser is acquiring from the Sellers, among other things, the Business Intellectual Property, including all of Sellers' Marks, in each case, whether registered or unregistered, and trademark and service mark applications, including, without limitation, those Marks and applications listed in Schedule I hereto (all of the foregoing are referred herein collectively as the "Assigned Trademarks"). Capitalized terms used herein have the meanings assigned to such terms in the Purchase Agreement; and

WHEREAS, the contemporaneous execution and delivery of this Assignment by the Sellers is a condition to the obligations of the Purchaser to consummate the transactions contemplated by the Purchase Agreement;

**AGREEMENT:**

In consideration the payment of the Purchase Price and the assumption of the Assumed Liabilities by the Purchaser, the receipt and sufficiency of which is hereby acknowledged, the Sellers do hereby make and deliver this Assignment and agree as follows:

1. Assignment of Assigned Trademarks. In accordance with Section 1.1 of the Purchase Agreement, the Sellers do hereby sell, convey, transfer, assign and deliver to the Purchaser and its successors and assigns, and the Purchaser hereby accepts from such Seller, all of the worldwide right, title, and interest of each Seller in, to, and under all of the Assigned Trademarks, free and clear of all Liens (other than Permitted Liens), including, without limitation, all common law trademarks for which no applications or registrations exist, all applications to register any of the Assigned Trademarks, and all registrations that have been or may be granted for any of the Assigned Trademarks, together with all common law rights associated with the applications and registrations, and all goodwill associated with the Assigned Trademarks and symbolized thereby, together with the right to sue and recover damages for past, present and future infringements, unauthorized use, misappropriation, dilution or violation by any Person of the Assigned Trademarks and to fully and entirely stand in the place of such Seller in all matters related to the Assigned Trademarks.

2. Terms of the Purchase Agreement. The terms of the Purchase Agreement, including the Sellers' representations, warranties, covenants, agreements and indemnities relating to the Assigned Trademarks, are incorporated herein by this reference. The Sellers acknowledge and agree that the representations, warranties, covenants, agreements and indemnities contained in the Purchase Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. Nothing contained in this Assignment will be deemed

to supersede, modify, limit or amend any of the rights, duties or obligations of the parties under the Purchase Agreement, this Assignment being intended only to effect the transfer of the Assigned Trademarks to the Purchaser, as contemplated in the Purchase Agreement. In the event of any conflict or inconsistency between the terms of the Purchase Agreement and the terms hereof, the terms of the Purchase Agreement shall govern.

3. Further Assurances. Following the date of this Assignment, each Seller shall, at the Purchaser's request, and shall cause each of their respective Affiliates and successors and assigns to, from time to time, execute, acknowledge and deliver any and all further acts, conveyances, transfers, assignments, assurances, affidavits, testimonies, declarations, oaths, samples, exhibits, specimens, and other documentation, as may be required to effect the terms of this Assignment and its recordation in relevant state and national trademark offices.

4. No Third Party Beneficiaries. This Assignment shall be binding upon and inure solely to the benefit of the Purchaser and the Sellers and each of their respective successors and assigns and nothing herein, express or implied, is intended to or shall confer upon any other Person, any legal or equitable right, benefit or remedy of any nature whatsoever, under or by reason of this Assignment.

5. Counterparts. This Assignment may be executed and delivered (including by electronic or facsimile transmission) in one or more counterparts, and by the different parties hereto in separate counterparts, each of which when executed shall be deemed to be an original, but all of which taken together shall constitute one and the same agreement.

6. Governing Law. EXCEPT TO THE EXTENT THAT FEDERAL LAW PREEMPTS STATE LAW WITH RESPECT TO THE MATTERS COVERED HEREBY, THIS ASSIGNMENT SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF DELAWARE WITHOUT GIVING EFFECT TO ANY CONFLICT OF LAW PROVISION (WHETHER OF THE STATE OF DELAWARE OR ANY OTHER JURISDICTION) THAT WOULD CAUSE THE APPLICATION OF THE LAWS OF ANY JURISDICTION OTHER THAN THE STATE OF DELAWARE.

7. Jurisdiction; Waiver of Jury Trial. The provisions of the Purchase Agreement set forth in Article VIII thereof under the headings "Jurisdiction" and "Waiver of Jury Trial" are incorporated herein by reference as if set forth in full herein and shall apply to the terms and provisions of this Assignment and the parties hereto *mutatis mutandis*.


