## ASSIGNMENT OF TRADEMARKS

This Agreement is made and entered into this 15<sup>th</sup> day of December, 2014 (“Effective Date”), by and between Specialty Fertilizer Products, LLC (hereinafter “SFP”), a limited liability company duly organized under the laws of the State of Ohio having an address 11550 Ash Street, Suite 220, Leawood, Kansas 66211; and Verdesian Life Sciences, LLC (hereinafter “VLS”), a limited liability company duly organized under the laws of the State of Delaware having an address of 501 Cascade Pointe Lane, Suite 103, Cary, North Carolina 27513.

WHEREAS, SFP has adopted and used or has a *bona fide* intention to use (itself or through a licensee) a number of trademarks (hereinafter “the Marks”);

WHEREAS, SFP has pursued registration for the Marks in various countries around the world, and SFP presently owns a number of pending applications and issued registrations covering the Marks (hereinafter “the Applications and Registrations”), each of which is enumerated in the Exhibit attached hereto; and

Whereas, VLS is desirous of acquiring all right, title, and interest in, to, and under the Marks and the Applications and Registrations.

Now, therefore, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, SFP and VLS hereby agree as follows:

1. SFP has sold, assigned and transferred, and by these presents does sell, assign and transfer, unto VLS the full and exclusive right, title and interest, throughout the world, in, to and under the Marks and the Applications and Registrations, together with the good will of the business symbolized by the Marks, including any and all portions of SFP’s business to which the Marks pertain to the extent that such business is ongoing and existing, and the right to sue for and collect on all claims for damages by reason of past infringement of the Marks or the Registrations.
2. At VLS’s request, SFP shall provide non-monetary assistance to VLS in registering, perfecting, enforcing or defending VLS’s rights in the Marks, including, but not limited, execution of any necessary documents.

IN WITNESS WHEREOF, this Agreement has been duly executed and delivered by the duly authorized officer of each party hereto as of the Effective Date.

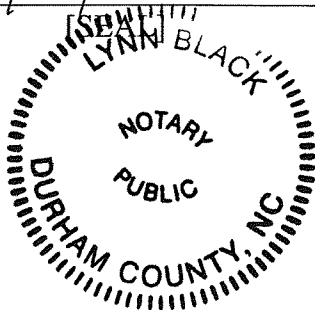

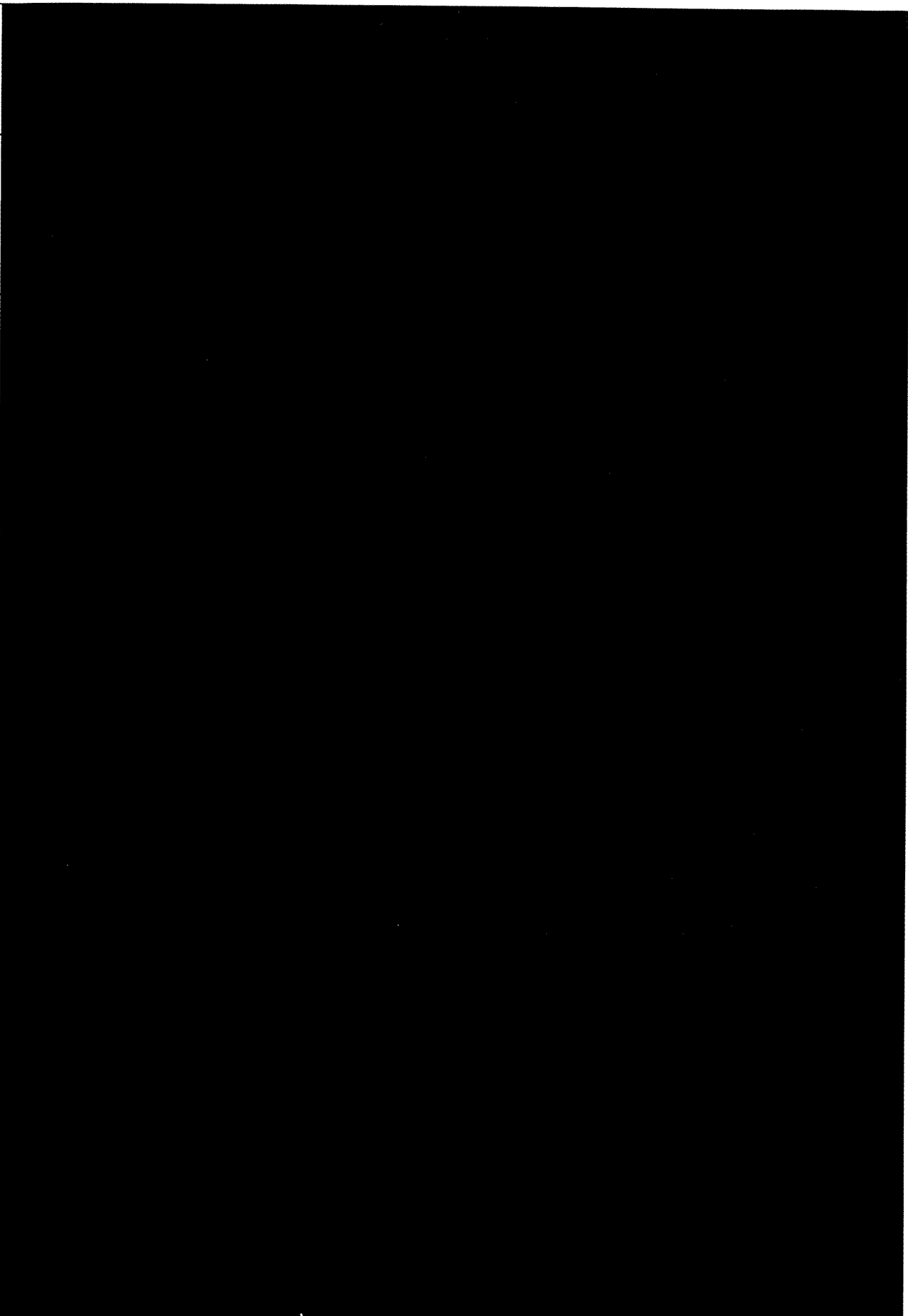

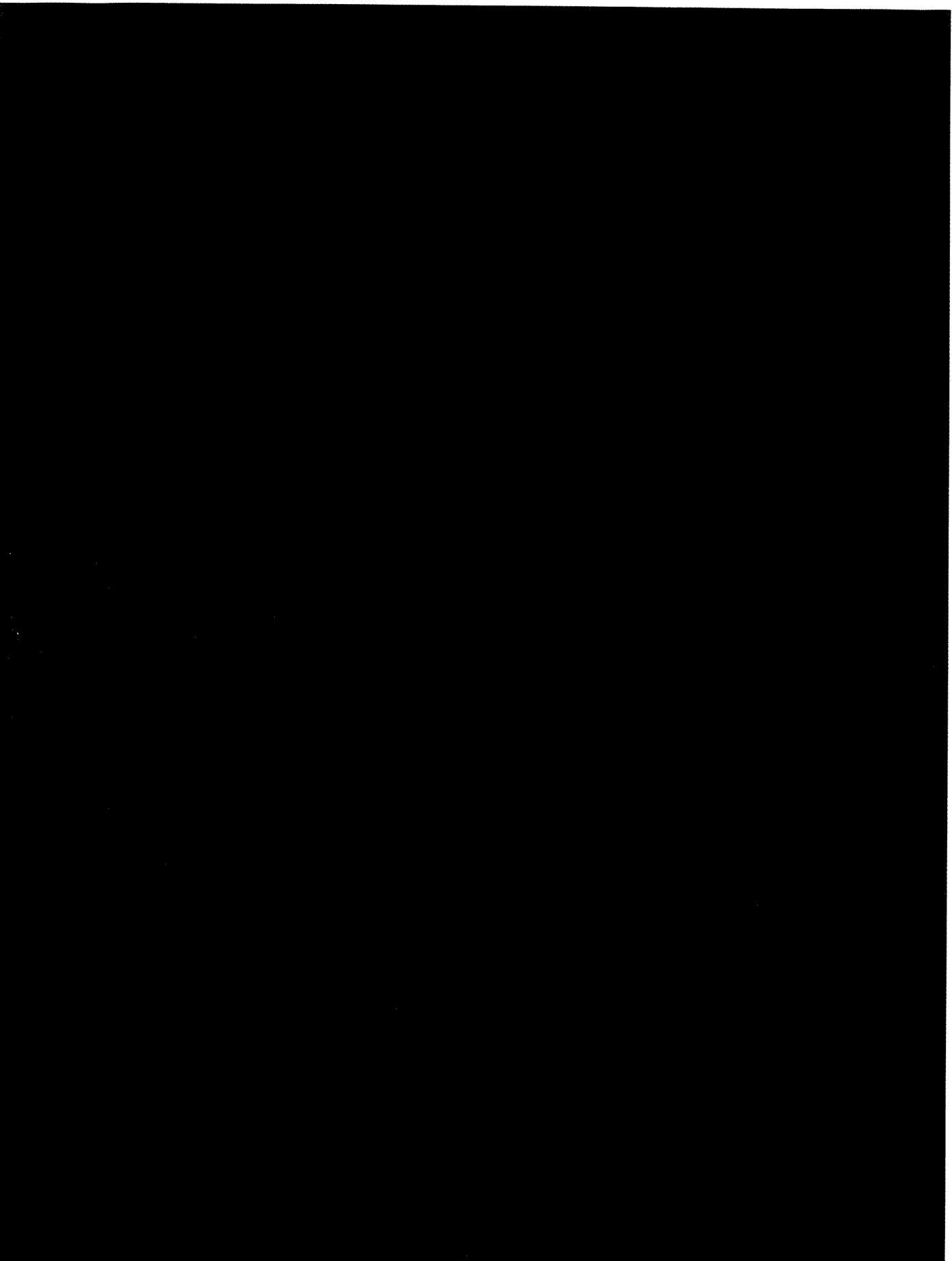
