**RELEASE OF SECURITY INTEREST IN  
TRADEMARK COLLATERAL**

This RELEASE, dated as of December 17, 2014, is made by COBIZ BANK, a Colorado corporation dba Colorado Business Bank, ("CoBiz"), pursuant to the Loan and Security Agreement, dated as of January 31, 2012 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Loan Agreement"). NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, CoBiz agrees as follows:

CoBiz hereby TERMINATES, without recourse, representation or warranty the Agreement, and RELEASES, without recourse, representation or warranty its lien on and security interest in all of the Trademark Collateral, including the trademark registration set forth in Schedule I, attached hereto and incorporated herein by reference.

CoBiz agrees to provide the Grantor with any additional authorization reasonably necessary to effect the release of its security interest in the Trademark Collateral.
