RELEASE

OF

INTELLECTUAL PROPERTY SECURITY AGREEMENT

WHEREAS, PRO NVEST, INC., a Delaware corporation ("Pro Nvest"), and SIGNIX, INC., a Delaware corporation ("Signix"), were indebted to LIVINGSTON FUND I, L.P., a Georgia limited partnership (the "Lender"); and

WHEREAS, Pro Nvest and Signix, as security for that indebtedness, did grant to Lender a security interest in all of their right, title and interest in, to and under certain trademarks, trademark registrations and applications for trademark registration, including those referred to in Schedule A attached hereto and hereby made a part hereof, and in certain patents including those referred to in Schedule A, as set forth in the Intellectual Property Security Agreement executed and effective as of March 24, 2004 (the "Security Agreement") and recorded in the United States Patent and Trademark Office at Reel 3059, Frame 494 on March 29, 2004; and


WHEREAS, said security interest is no longer required.

NOW, THEREFORE, Lender does hereby release and relinquish to Pro Nvest and Signix all its right, title and interest in, to and under the aforesaid trademarks and patents, and in, to and under the aforesaid Intellectual Property Security Agreement, and does hereby agree that the filing of Security Agreement with the United States Patent and Trademark office may be removed of record in its entirety by the filing of this Release with the United States Patent and Trademark Office, and wherever else such filing may be needed.

AND Lender confirms that no Event of Default has been declared under the aforesaid Security Agreement and that any technical occurrence of any Event of Default under the Security Agreement has been waived, and Lender hereby reassigns and confirms to Pro Nvest and Signix any and all right, title and interest, if any, which it may have acquired in, to and under any patents, trademarks or other Collateral pursuant to the Security Agreement.

This Release shall be binding upon and inure to the benefit of Lender, Pro Nvest and Signix, and their respective successors and assigns.
