**RELEASE OF SECURITY INTEREST IN  
TRADEMARK COLLATERAL**

This RELEASE, dated as of December 17, 2014, is made by Bank of America, N.A., as administrative agent (in such capacity, the "Administrative Agent") under (i) that certain Amended and Restated Credit and Guaranty Agreement, dated as of December 19, 2013 (as amended, modified, extended, restated, replaced, or supplemented prior to the date hereof, the "Existing Credit Agreement"), (ii) that certain Trademark Security Agreement dated as of September 30, 2010 (Reel No. 004287/Frame No. 0712) as supplemented by Supplement No. 1 To Trademark Security Agreement dated as of June 24, 2013 (Reel No.005055/Frame No. 0327), and by Supplement No. 2 To Trademark Security Agreement dated as of December 19, 2013 (Reel No.005179/Frame No. 0788) and (iii) that certain Trademark Security Agreement dated as of May 17, 2012 (Reel No. 004790/Frame No. 0779) (clauses (ii) and (iii) collectively, the "Trademark Security Agreements").

**W I T N E S S E T H**

WHEREAS, Creative Artists Agency, LLC ( "CAA"), CAIC, LLC (together with CAA, the "Grantors"), and Bank of America, N.A., as Administrative Agent are parties to one or more of the Trademark Security Agreements.

WHEREAS, pursuant to the Trademark Security Agreements, each Grantor granted to the Administrative Agent for the ratable benefit of the Secured Parties a security interest in all of such Grantor's right, title and interest in and to the Trademark Collateral, as collateral security for satisfactory performance and payment of the Obligations. Unless otherwise defined here, capitalized terms have the meaning given to them in the Trademark Security Agreements.

WHEREAS, each Grantor has requested that the Administrative Agent terminate and release its security interest in all of its right, title and interest in and to its Trademark Collateral and associated goodwill, including those trademarks set forth in Schedule I.

NOW, THEREFORE, the Administrative Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse its security interest in all of its right, title and interest in and to the Trademark Collateral, including the trademark registrations and trademark applications set forth in Schedule I, attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral are hereby discharged, terminated and released and hereby transfers and assigns to each respective Grantor any and all right, title and interest that the Administrative Agent may have obtained in, to and under the Trademark Collateral under the Trademark Security Agreements.

The Administrative Agent agrees to provide the Grantors with any information and additional authorization reasonably necessary to effect the release of the Administrative Agent's security interest in the Trademark Collateral.
