**CERTIFICATE REGARDING TERMINATION OF SECURITY
INTEREST HELD BY COAST BUSINESS CREDIT, A DIVISION
OF SOUTHERN PACIFIC BANK**

I, the undersigned, Kevin Mischnick, am the VP-Finance of MULTIMEDIA GAMES, INC., of 206 Wild Basin Road South, Bldg B, 4th Floor, Austin, TX 78746, U.S.A. ("MGAM"), and am authorized to sign on behalf of MULTIMEDIA GAMES, INC.

In that representative capacity, and not in any personal capacity, I do hereby certify that:

1. MGAM entered into a \$10 million credit facility with Coast Business Credit, a division of Southern Pacific Bank ("Bank") on July 29, 1999, pursuant to which certain assets of MGAM were used to secure the credit facility. The credit facility was paid in full and terminated September 28, 2001, according to filings submitted to the Securities & Exchange Commission (SEC), to wit:

and that all security interests and liens granted to the Bank under the credit facility have been de facto terminated and released.

2. Reference is made to the recordings with respect to the security interest under such credit facility made with the United States Patent and Trademark Office, with the Patents Divisions at Reel and Frames 010121/092; and 011369/0930, with the Trademarks Divisions at Reel and Frames 2203/0593 and 1934/0427), and with the United States Copyright Office at Volume and Document numbers V3429 D808 and V3462 D390.
3. We have been advised that Southern Pacific Bank is defunct and ceased to exist as an entity in 2003, and therefore cannot execute appropriate documentation evidencing the termination and release of the security interest recorded under the Reel/Frame numbers and the Volume/Document numbers referenced above.
4. Accordingly, this Certificate is being submitted for recording with the United States Patent and Trademark Office and the United States Copyright Office to confirm the termination and release of the security interest held by the Bank for all intellectual properties (patents, trademarks and copyrights) in the Reel/Frame numbers and Volume/Document numbers referenced above, including those specified patents, trademarks and copyrights listed in Exhibit A attached hereto, owned by MGAM and its affiliates.

5. We have searched our internal legal and financial records for any further information concerning the credit facility and have found none and nothing to the contrary of the above statements.



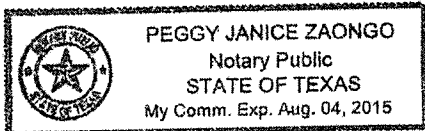


