## TRADEMARK ASSIGNMENT

## RECITALS

A. Assignor and Assignee have entered into that certain Stock and Asset Purchase Agreement dated as of September 12, 2014 (as amended or otherwise modified from time to time, the "SAPA"). Capitalized terms used but not defined herein shall have the meanings given to them in the SAPA.

B. This Trademark Assignment is contemplated by Section 2.4(c) of the SAPA.

## AGREEMENT

Assignor hereby transfers, assigns and delivers to Assignee, all of Assignor's worldwide right, title and interest in, to and under the Trademarks listed on Exhibit A attached hereto, including and any and all registrations, applications for registration, renewal registrations and applications for renewal registrations, extensions and foreign counterparts therefor or thereof that may hereafter be secured under the laws now or hereafter in effect in the United States or in any other jurisdiction (collectively, the "Assigned Trademarks"), together with the ongoing business and goodwill symbolized by the Assigned Trademarks, as well as all rights to sue for and recover and retain past and future legal or equitable relief, including damages, costs, expenses or attorneys' fees, for infringement of the Assigned Trademarks, the same to be held and enjoyed by Assignee, its successors and assigns from and after the date hereof as fully and entirely as the same would have been held and enjoyed by Assignor had this Trademark Assignment not been made.


