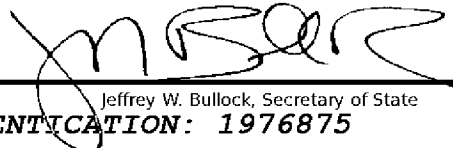

(an Illinois corporation)

WITH AND INTO  
ENCORE REPAIR SERVICES DE, LLC  
(a Delaware limited liability company)

It is hereby certified that:

1. The name and state of organization of each of the constituent entities are:

(a) Encore Repair Services DE, LLC, a Delaware limited liability company (hereinafter sometimes referred to as "New Encore" and sometimes as the "Surviving Entity"); and

(b) Encore Repair Services, Inc., an Illinois corporation (hereinafter sometimes referred to as the "Company" and sometimes together with New Encore as the "Constituent Entities").

2. An Agreement and Plan of Merger by and between the Company and New Encore, dated as of December 17, 2014 (hereinafter referred to as the "Merger Agreement") has been approved and executed by each of the Constituent Entities.

5. The Merger Agreement is on file at the office of the Surviving Entity located at 105 Prairie Lake Road, Unit D, East Dundee, Illinois 60118.

6. A copy of the Merger Agreement will be furnished by the Surviving Entity, on request and without cost, to any shareholder of the Company and to any member of New Encore.
