**RELEASE OF SECURITY INTEREST IN  
INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE, dated as of December 19, 2014, is made by CORTLAND CAPITAL MARKET SERVICES LLC (as successor administrative agent to ATALAYA ADMINISTRATIVE LLC, the successor administrative agent to WELLS FARGO CAPITAL FINANCE, LLC, formerly known as WELLS FARGO FOOTHILL, LLC), in its capacity as administrative agent for the Lenders (in such capacity, together with its successors and assigns in such capacity, the "Administrative Agent"), pursuant to the (i) Credit Agreement, dated as of May 23, 2008 (as amended, restated or otherwise modified from time to time, the "Original Credit Agreement") and (ii) Amended and Restated Credit Agreement dated as of April 3, 2012 (as amended, restated or otherwise modified from time to time, the "A&R Credit Agreement"). Capitalized terms not otherwise defined herein have the meaning assigned to them in the Original Credit Agreement or the A&R Credit Agreement, as applicable.

**W I T N E S S E T H**

WHEREAS, Publishing Group of America, Inc., a Tennessee corporation (the "Borrower") is party to each of the Credit Agreement and the A&R Credit Agreement;

WHEREAS, (i) pursuant to the Credit Agreement, the Borrower executed the Trademark Collateral Agreement dated May 23, 2008 (the "Trademark Collateral Agreement") and recorded with the U.S. Patent and Trademark Office ("USPTO") on May 30, 2008 at Reel/Frame No. 3791/0416 and (ii) pursuant to the A&R Credit Agreement, the Borrower executed the First Amendment to Trademark Collateral Agreement dated April 3, 2012 (the "First Amendment") and recorded with the USPTO on April 4, 2012 at Reel/Frame No. 4751/0186, in each case, pursuant to which the Borrower granted to the Administrative Agent a security interest in and to the entire right, title and interest of Borrower in (including without limitation, a lien on and pledge of) and to the Collateral (as defined in the Trademark Collateral Agreement);

WHEREAS, pursuant to the Credit Agreement, the Borrower executed the Copyright Mortgage dated May 23, 2008 (the "Copyright Mortgage") and recorded with the U.S. Copyright Office ("USCO") on June 5, 2008 at V3565 D313, pursuant to which the Borrower granted to the Administrative Agent a mortgage and security interest in (including without limitation, a lien on and pledge of) all of the Copyright Collateral (as defined in the Copyright Mortgage);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent agrees as follows:

The Administrative Agent hereby TERMINATES, without recourse, representation or warranty the Trademark Collateral Agreement, First Amendment, and Copyright Mortgage, and RELEASES, without recourse, representation or warranty their security interest in all of the Collateral and Copyright Collateral, including the trademark registrations, trademark applications, and copyright registrations set forth in Schedule I, attached hereto and incorporated herein by reference.

The Administrative Agent agrees to provide the Borrower with any additional authorization reasonably necessary to effect the release of the Administrative Agent's security interest in the Collateral and the Copyright Collateral.
