INTEREST IN U.S. TRADEMARKS**


FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, StoneMor Operating LLC, a Delaware limited liability company (“the Debtor”) with principal offices at 311 Veterans Highway, Suite B, Levittown, Pennsylvania, hereby assigns and grants to Bank of America, N.A., as Secured Party (the “Assignee”) with principal offices at 4 Penn Center, 1600 John F. Kennedy Boulevard, Philadelphia, Pennsylvania, a security interest in (i) all of the Debtor’s right, title and interest in and to the trademarks, trademark registrations and trademark applications (the “Marks”) set forth on Schedule A attached hereto together with (ii) all Proceeds (as such term is defined in the Security Agreement referred to below) of the Marks, (iii) the goodwill of the businesses with which the Marks are associated and, (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks and Patents or unfair competition regarding the same.

THIS ASSIGNMENT OF SECURITY INTEREST (this “Assignment”), effective as of December 19, 2014, is made to secure the satisfactory performance and payment of all the Secured Obligations of the Debtor, as such term is defined in the Second Amended and Restated Security Agreement, among Debtor, the other debtors from time to time party thereto and the Assignee, dated December 19, 2014 (as amended, restated, modified and/or supplemented from time to time, the “Security Agreement”).

This Assignment has been granted in conjunction with the security interest granted to the Assignee under the Security Agreement. The rights and remedies of the Assignee with respect to the security interest granted herein are without prejudice to, and are in addition to those set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Assignment are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.

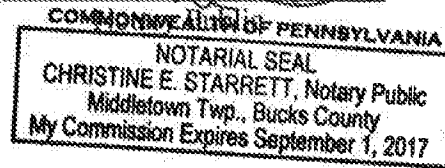

