**RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This RELEASE, dated as of December 18, 2014, is made by Goldman Sachs Lending Partners LLC, as collateral agent for each of the Secured Parties (together with any successors and permitted assigns thereto in such capacity, the "Agent"), in favor of CBI Research, Inc., a Massachusetts corporation (the "Grantor") as follows:

**W I T N E S S E T H**

WHEREAS, pursuant to the Second Lien Pledge and Security Agreement dated as of June 6, 2013 (as such agreement may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), by and among Advanstar Communications, Inc., as borrower (the "Borrower"), the Grantor, the other grantors party thereto and the Agent, and the Notice of Grant of Security Interest In Trademarks, dated as of June 6, 2013 (the "Trademark Notice"), by and among the Borrower, the Grantor, the other grantors party thereto and the Agent and recorded with the U.S. Patent and Trademark Office on June 21, 2013 at Reel/Frame No. 5054/0306, the Grantor granted the Agent, for its benefit and the ratable benefit of the Secured Parties, a continuing security interest (the "Security Interest") in all of the Grantor's right, title and interest in, to and under the Trademark Collateral, including, without limitation, the Trademarks set forth on Schedule A attached hereto;

WHEREAS, (i) the Borrower has paid, for the benefit of the Secured Parties, all outstanding Obligations to the Agent, and (ii) no Letter of Credit remains outstanding under the Credit Agreement; and

WHEREAS, the Grantor has requested that the Agent release its Security Interest in the Trademark Collateral.

NOW, THEREFORE, the Agent, on behalf of the Secured Parties, without recourse, representation or warranty and at the Grantor's sole cost and expense, hereby terminates, cancels and releases the Security Interest in the Trademark Collateral and any and right, title and interest of the Agent in the Trademark Collateral shall hereby terminate, cease and become void.

The Agent agrees to provide the Grantor with any information and additional authorization and documentation necessary to effect the release of the Agent's Security Interest in the Trademark Collateral (without recourse, representation or warranty and at the Grantor's sole cost and expense).

Capitalized terms used herein without definition are used as defined in the Security Agreement or Trademark Notice, as applicable.
