**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

TERMINATION AND RELEASE dated as of December _18_, 2014 from Hayfin Capital Management LLP (formerly called Haymarket Financial LLP), as security agent for itself and other other secured parties (“Security Agent”) under that certain Security Agreement (as defined below), in favor of Proserv Operations, Inc. (the “Grantor”).

WITNESSETH:

WHEREAS, the Grantor entered into that certain Security Agreement, dated as of June 21, 2011 as may be amended from time to time (the “Security Agreement”), among the Grantor, the Security Agent, and other parties thereto;

WHEREAS, pursuant to the Security Agreement, Grantor executed an Intellectual Property Security Agreement (the “IP Security Agreement”), dated as of May 9, 2012, in favor of the Security Agent, pursuant to which the Grantor granted to the Security Agent a continuing security interest in all of the Grantor’s right, title and interest in, to and under the United States Trademark registrations and applications listed in Schedule A (the “Trademarks”), together with the goodwill of the business connected with the use thereof and symbolized thereby, and all rights to sue or otherwise recover for any past, present, or future infringement or other violation or impairment of any of the foregoing (the “Security Interest”), which was recorded in the United States Patent and Trademark Office (“USPTO”) on May 10, 2012 at Reel/Frame No. 4776/0818;


WHEREAS, the Security Agent now desires to terminate and release its Security Interest in the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, the Security Agent hereby releases, terminates and discharges the Security Interest assigned to it under the Trademark Security Agreement, and any and all rights, title or interests of the Security Agent in, to and under the Security Interest shall hereby terminate, cease and become void. The Security Agent hereby consents to the recording of the release of the Security Interest contemplated hereby with the USPTO. Capitalized terms used herein and not otherwise defined herein shall have the respective meanings provided in the Security Agreement.
