**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS dated as of ~~22 December~~, 2014, from Barclays Bank PLC, a UK private limited company, located at 5 The North Colonnade, London E14 4BB as Security Agent (in such capacity, the "Agent") for the Lenders, to Northgate Information Solutions UK Limited, a UK private limited company, located at Peoplebuilding 2, Peoplebuilding Estate Maylands, Avenue Hemel Hempstead, Hertfordshire HP24NW, United Kingdom (the "Grantor").

WITNESSETH:

WHEREAS, (a) Northgate Information Solutions Limited (previously known as NIS Holdings No. 5 Limited) ("Holdco"), certain banks and other financial institutions or entities ("Senior Lenders") and the Agent entered into the Senior Facilities Agreement, dated March 5, 2008 (as amended, restated, extended, supplemented and/or otherwise modified from time to time, the "Senior Facilities Agreement"), pursuant to which the Senior Lenders severally agreed to make certain extensions of credit to the Borrowers (as defined in the Senior Facilities Agreement) upon the terms and conditions set forth therein (b) Holdco, certain banks and other financial institutions or entities ("Subordinated Lenders") and the Agent entered into the Subordinated Facility Agreement, dated March 5, 2008 (as amended, restated, extended, supplemented and/or otherwise modified from time to time, the "Subordinated Facility Agreement," and together with the Senior Facilities Agreement, the "Credit Agreements"), pursuant to which the Subordinated Lenders severally agreed to make certain extensions of credit to the Borrowers (as defined in the Subordinated Facility Agreement) upon the terms and subject to the conditions set forth therein;

WHEREAS, in connection with the Credit Agreements, a security interest (the "Security Interest") was granted by the Grantor to the Agent in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, pursuant to that certain Grant of Security Interest in Trademark Rights dated as of April 19, 2011 among the Agent and Grantor (the "Security Agreement"), Grantor, by reference to the Credit Agreement, reaffirmed its intent to grant a Security Interest to the Agent specifically in certain Trademark Collateral;

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on April 26, 2011 at Reel 4528, Frame 0781 and on April 26, 2011 at Reel 4528, Frame 0839; and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities of the Grantor secured by the Trademark Collateral

pursuant to the Credit Agreements, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:


1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the Trademarks listed on Schedule A hereto. The term "Trademarks" shall have the meaning provided by reference in the Guarantee and Collateral Agreement and the Security Agreement.

2. Release of Security Interest. The Agent hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of the Agent in such Trademark Collateral shall hereby cease and become void.

3. Further Assurances. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.

IN WITNESS WHEREOF, the undersigned has executed this Termination and Release by its duly authorized officer as of the date first above written.
