Without limiting the foregoing, the present assignment includes, and to the extent that a conveyance is not now possible or effective Assignor hereby agrees to assign as soon as practicable, all past, present and future rights in and related to mark(s) which are colorable imitations of, or that are confusingly similar to the above-identified mark, together, as and when applicable, with the goodwill appurtenant

thereto. The right to receive future assignments hereunder shall convey, as applicable, to Assignee's successors and assigns. The present assignment includes, without further consideration or remuneration, all claims or causes of action against third parties (including Assignee), known or unknown, that relate, or hereafter accrue in relation to any right or property assigned in relation to this agreement.

Assignor represents and warrants that it is the sole owner of all conveyed rights and interests and has full right to make this assignment. Assignor agrees that it will communicate to Assignee or its representatives any material facts known to Assignor respecting said conveyed rights and interests, including those as may be conveyable in the future pursuant to the preceding paragraph. Assignor agrees to cooperate with Assignee or its successors or assigns in any legal proceeding pertaining to the assigned rights and interests, and, upon reasonable request, to cause knowledgeable representatives to be available to Assignee's then counsel for testifying or otherwise providing information in connection with such proceedings. Assignor agrees to sign all lawful papers, make all rightful oaths, and generally do everything possible to aid said Assignee, its successors, assigns and nominees, to perpetuate and enforce trademark protection for the said trademark.
