RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, Dwellworks, LLC, a Delaware limited liability company; Dwellworks Residential Services, LLC, a Delaware limited liability company; Relocation Assistance, Inc., a Michigan corporation; Destination Support Services, LLC, a Delaware limited liability company; Dwellworks Destination Services, LLC, a Delaware limited liability company; Full Circle International Relocations, Inc., a Virginia corporation; and Dwellworks Property Advisors, LLC, a New York limited liability company (collectively, the "Debtors") is the owner of the trademarks listed on Schedule A attached hereto, which trademarks are registered in the United States Patent and Trademark Office (the "Office") (all such trademarks, registrations and applications, collectively the "Trademarks"); and

WHEREAS, in order to secure certain indebtedness, the Debtors entered into an Intellectual Property Security Agreement (the "Security Agreement"), dated as of July 20, 2011, in favor of The Huntington National Bank, (the "Bank"), with offices at 200 Public Square, Cleveland, Ohio 44114, and pursuant thereto executed and delivered a Notice of Security Interest (the "Notice") as recorded in the Office on August 1, 2011 at Reel 4597 and Frame 0197, pursuant to which the Debtors granted to the Bank, according to the terms of the Security Agreement, a security interest in all of its right, title and interest in and to the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank does hereby release and relinquish, and does hereby reassign to the Debtors, without representation or warranty, all of the Bank's right, title and interest in and to the Trademarks listed on the attached Schedule A, and the use thereof, together with all proceeds and products thereof and the goodwill of the businesses symbolized by the Trademarks, and does hereby agree that the filing of the Notice in the Office as aforesaid may be removed from the record.
