**RELEASE OF SECURITY INTERST IN TRADEMARKS**


**WHEREAS**, in order to secure certain indebtedness, the Debtors entered into an Intellectual Property Security Agreement (the "Security Agreement"), dated as of July 20, 2011, in favor of The Huntington Capital Investment Company (the "Bank"), with offices at 41 South High Street, Columbus, Ohio 43215, and pursuant thereto executed and delivered a Notice of Security Interest (the "Notice") as recorded in the Office on August 3, 2011 at Reel 4598 and Frame 0429, pursuant to which the Debtors granted to the Bank, according to the terms of the Security Agreement, a security interest in all of its right, title and interest in and to the Trademarks.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank does hereby release and relinquish, and does hereby reassign to the Debtors, without representation or warranty, all of the Bank's right, title and interest in and to the Trademarks listed on the attached Schedule A, and the use thereof, together with all proceeds and products thereof and the goodwill of the businesses symbolized by the Trademarks, and does hereby agree that the filing of the Notice in the Office as aforesaid may be removed from the record.
