AND, the Corporation hereby warrants and covenants that it has full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreements inconsistent herewith.

AND, the Corporation agrees to execute any instruments and to perform any acts which may be necessary to fully effectuate and record this Trademark Assignment.

AND, this Trademark Assignment is executed and delivered pursuant to the terms and conditions of the Asset Purchase Agreement which are incorporated herein by reference and made a part hereof.



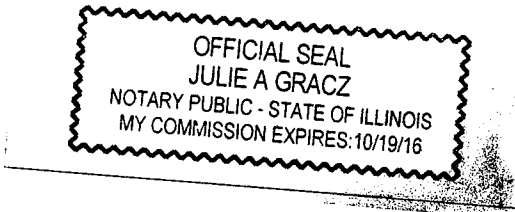
