**RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release"), dated as of December 14, 2014, is made by **TEXAS CAPITAL BANK, N.A.** (the "Lender"), under the Trademark Security Agreement referred to below.

The Lender agrees, at the Company's expense, to cooperate with the Company to provide the Company with any additional information or authorization reasonably required or desirable to effect the release of the Lender's security interest in the Trademark Collateral.
