RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This **RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this "**Release**"), dated as of December 14, 2014, is made by **TEXAS CAPITAL BANK, NATIONAL ASSOCIATION**, as collateral agent (the "**Agent**") under the Intellectual Property Security Agreement referred to below.

WHEREAS, Future Food, Inc., a Delaware corporation ("**Parent**"), Future Food, Ltd., a Texas limited partnership (the "**Future Food**"), and Future Food GP, Inc., a Delaware corporation ("**GP**" and together with Future Food and Parent, each a "**Company**" and collectively, the "**Companies**") are a party to that certain Intellectual Property Security Agreement, dated as of November 19, 2004 (the "**Intellectual Property Security Agreement**") made by the Companies in favor of the Agent pursuant to which each Company granted to the Agent a security interest in all of the right, title and interest of such Company in and to the IP Collateral (as defined in the Intellectual Property Security Agreement), including, without limitation, the trademarks listed on Annex I attached hereto; and


WHEREAS, the Intellectual Property Security Agreement was recorded in the U.S. Patent and Trademark Office on December 15, 2004, on Reel/Frame 002994/0752.

NOW THEREFORE, the Agent hereby releases, without representation, recourse or warranty whatsoever, its security interest in the IP Collateral granted pursuant to the Intellectual Property Security Agreement, and the Agent hereby reassigns any and all such right, title and interest that the Agent may have in the IP Collateral to the applicable Company having granted a security interest in such IP Collateral.

The Agent agrees, at the Companies' expense, to cooperate with the Companies to provide the Companies with any additional information or authorization reasonably required or desirable to effect the release of the Agent's security interest in the IP Collateral.
