ASSIGNMENT OF TRADEMARKS

This Assignment Agreement (this "Agreement") dated November 11, 2014, is by and between TalkPath LLC, a Nevada limited liability company ("Assignor") and Arkadin, Inc., a Delaware Corporation ("Assignee").

Assignor wishes to assign the Registered Trademarks, the Unregistered Trademarks, and the Foreign Trademarks to the Assignee, and Assignee wishes to accept the assignment of the Registered Trademarks, the Unregistered Trademarks, and the Foreign Trademarks from the Assignor pursuant to the terms and conditions set forth below.

1. Description of the Marks. The various marks Assignor desires to assign to the Assignee and Assignee desires to have assigned to it by Assignor are as follows:

a. Registered Trademarks. Assignor has adopted, used, and is using the following registered trademarks:

(i) "accuconference," United States Patent and Trademark Office Registration number 3,296,978;

(ii) "talkpath," United States Patent and Trademark Office Registration number 3,488,549;

(iii) "acculing," United States Patent and Trademark Office Registration number 4,451,338;

(iv) "face to face," United States Patent and Trademark Office Registration number 3,834,043;

(v) "blast dial," United States Patent and Trademark Office Registration number 3,440,161;

(vi) "meeting central," United States Patent and Trademark Office Registration number 4,587,961;

(vii) "Get Connected," United States Patent and Trademark Office Registration number 3,447,232 (the marks referred to in Sections 1(a)(i) through 1(a)(vii) are collectively referred to as the "Registered Trademarks").

b. Trademark Applications. Assignor has adopted, used, and is using the following marks and has applied to the United States Patent and Trademark Office to register such marks, such applications pending approval:

(i) "quickling," United States Patent and Trademark Office Serial number 86,298,915;

(ii) "Codeless," United States Patent and Trademark Office Serial number 86,310,724 (the marks referred to in Sections 1(b)(i) and 1(b)(ii) are collectively referred to as the "Unregistered Trademarks").

c. Trademarks in Foreign Jurisdictions. Assignor has adopted, used, and is using in Canada the registered trademark "AcuuConference," Canadian Intellectual Property Office Registration number TMA700601 (the "Foreign Trademark").

2. Assignment.

a. Assignment of Marks and Good Will. For good and valuable consideration, the receipt of which is hereby acknowledged, the Assignor hereby assigns to Assignee all rights, titles, and interests to the Registered Trademarks, the Unregistered Trademarks, and the Foreign Trademark (together, the "Marks") and the registrations thereof, together with the goodwill of the business in connection with which the Marks are used and which is symbolized by the Marks.

b. Assignment of Rights to Protect the Marks. Assignor further assigns any and all right to sue for, and recover damages and profits for, any past, present, or future infringements of the Marks.

c. Worldwide Rights. The assignment contemplated in Sections 2(a) and 2(b) shall transfer to Assignee all rights, duties, and obligations contemplated herein for any jurisdiction in which the Marks may be used, and Assignor shall have no further rights to the Marks in any jurisdiction, United States or foreign.

d. Additional Documents. Assignor agrees to execute and deliver, at the request of Assignee, all paper, instruments, and assignments, and to perform any other reasonable acts the Assignee may require to vest all Assignor's rights, titles, and interests in and to the Marks in the Assignee, including but not limited to the completion of the attached Exhibit A to effectuate the transfer of the AccuConference mark registered in Canada. Assignor further agrees to provide any evidence deemed necessary by the Assignee or the relevant governmental body to maintain or complete the registration of the Marks, to the extent such evidence is in the possession or control of the Assignor.


