I, Robin E. Silverman, a member of the New York Bar, and a partner of the firm Golenbock Eiseman Assor Bell & Peskoe LLP, 437 Madison Avenue, New York, New York 10022, am a Legal Representative of NewBay Media LLC.

1. I submit this Declaration to the Patent and Trademark Office ("PTO") to correct an error in the documentation of the chain of title for the following marks currently owned by NewBay Media LLC ("NewBay"): DV (Registration Number 1977500); DV (Registration Number 2157804); DV (Registration Number 2733574); DV DIGITAL VIDEO (Registration Number 2728342); DV DIGITAL VIDEO CERTIFIED (Registration Number 3142839); DV DIGITAL VIDEO EXPO (Registration Number 2124481); DV DIGITAL VIDEO MAGAZINE (Registration Number 2064166); DV EXPO (Registration Number 2841883); DV EXPO EAST (Registration Number 2783371); DV EXPO WEST (Registration Number 2783372); DV WEB VIDEO (Registration Number 2450360); DIGITAL VIDEO (Registration Number 1861495); DIGITAL VIDEO MAGAZINE (Registration Number 1861504); and TECHNOLOGY & LEARNING (Registration Number 1951628) (collectively, the "Trademarks").
2. Pursuant to an assignment document dated as of September 13, 2006, the Trademarks were assigned to NewBay by CMP Media LLC ("CMP") and the assignment was recorded by the PTO at Reel/Frame number 3390/0080 ("Assignment Document"). A copy of the Assignment Document so recorded, including the schedule of the trademarks conveyed by CMP to NewBay (which included the Trademarks), is attached hereto as Exhibit A and incorporated herein by reference.
3. Pursuant to a different assignment document dated as of September 13, 2006, NewBay acquired additional trademarks from a separate entity, CMP Entertainment Media, Inc. ("Entertainment"), and that assignment was recorded by the PTO at Reel/Frame number 3390/0116 ("Additional Assignment"). A copy of the Additional Assignment so recorded, including the schedule of the trademarks conveyed by Entertainment to NewBay, is attached hereto as Exhibit B and incorporated herein by reference.
4. An error was made on the cover sheet accompanying the Additional Assignment (characterizing Entertainment as a limited liability company) and accordingly, in January 2007, a correction of error form (which included a schedule of the trademarks against which the correction was to be recorded)

was filed with the PTO to properly identify CMP Entertainment Media, Inc. as a corporation. That correction form was recorded at the PTO at Reel/Frame number 3462/0419 ("Correction Form"). A copy of the Correction Form so recorded is attached hereto as Exhibit C and incorporated herein by reference.

5. The schedule attached to the Correction Form erroneously included the Trademarks. The inclusion of these Trademarks on such schedule was in error as the Trademarks had been conveyed to NewBay by CMP, and were not included in the Additional Assignment by Entertainment to which the Correction Form related.
6. Accordingly, Declarant hereby respectfully requests that this Declaration be recorded against each of the Trademarks set forth in Exhibit D, attached hereto and incorporated herein by reference, to clarify the chain of title to the Trademarks and correct any erroneous information relating thereto, so that the PTO records clearly identify NewBay as the owner of the Trademarks.
7. The undersigned being warned that willful false statements and the like are punishable by fine or imprisonment, or both, under 18 U.S.C. 1001, and that such willful false statements and the like may jeopardize the validity of the application or document or any registration resulting therefrom, declares that all statements made her own knowledge are true; and all statements made on information and belief are believed to be true.
