## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This Release of Security Interest in Trademarks, dated as of December 19, 2014 (the "Trademark Security Release"), is made by DEUTSCHE BANK TRUST COMPANY AMERICAS in its capacity as collateral agent (in such capacity, the "Collateral Agent") under that certain Term Loan Trademark Security Agreement, dated as of June 30, 2006 (as amended, supplemented or modified and in effect from time to time, the "Trademark Security Agreement") by and among ELLIS COMMUNICATIONS KDOC LLC (the "Grantor") and the Collateral Agent. Except as otherwise provided herein, capitalized terms used herein but not otherwise defined have the meanings set forth (or incorporated) in the Trademark Security Agreement.

WHEREAS, pursuant to the Trademark Security Agreement that was recorded in the records of the United States Patent and Trademark Office on July 11, 2006 at reel 3345, frame 0214 (with a corrective filing recorded on July 19, 2006 at reel 3377, frame 0326 in connection therewith), the Grantor granted to the Collateral Agent a security interest in all of Grantor's right, title and interest in and to certain collateral identified in the Trademark Security Agreement, including, without limitation, the trademark registration described on attached Schedule I (the "Trademark Collateral");

WHEREAS, the Obligations secured by the Trademark Collateral have been repaid; and


WHEREAS, the Grantor has requested and the Collateral Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release and discharge of its security interest in the Trademark Collateral (the "Released Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Collateral Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the security interest created under the Trademark Security Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, and (c) discharge any and all rights, title and interest it has in, and the security interest granted to the Agent in the Released Collateral.
