TRADEMARK ASSIGNMENT

RECITALS

WHEREAS, Assignor has agreed to transfer, convey, and assign all right, title, and interest in and to the Trademarks to the Assignee, and Assignee desires to acquire all of Assignor's right, title, and interest in and to the Trademarks.

NOW, THEREFORE, for and in consideration of Ten Dollars (\$10.00) and other good and valuable consideration contained herein, the receipt and sufficiency of which are hereby acknowledge, the Parties hereby agrees as follows:

1. Assignment of Trademarks. Assignor hereby irrevocably grants, conveys, transfers and assigns to Assignee all of Assignor's right, title, and interest, throughout the world, in and to the Trademarks (including, without limitation, common law rights, all applications and registrations for the Trademarks, and all rights to further register and obtain renewals and extensions of registrations for the Trademarks and all rights to sue for past infringement and to collect and retain all damages and profits therefrom), together with all goodwill symbolized by and associated with the Trademarks.

2. Recordation of Assignment. The Parties hereby request and authorize the relevant authority at the United States Patent and Trademark Office and/or the applicable foreign authorities to record Assignee as a the Assignee and full owner of all right, title, and interest in and to the Trademarks.

3. Obligation to Assist. The Parties agree to execute any and all other assignments, documents, certificates and other instruments as may at any time be deemed reasonably necessary to further evidence or consummate this Assignment or to renew or maintain the Trademarks at the United States Patent and Trademark Office and/or the applicable foreign authorities. If required to sue for

infringement and to collect and retain all damages and profits therefrom, each Party hereby agrees to join the other Party in any action in a court of law or a governmental agency.

4. Applicable Law. This Assignment shall be governed by and construed in accordance with the laws of the State of Georgia without regard to its principles of conflicts of laws.

5. Entire Agreement. This Assignment contains the Parties entire agreement and may only be changed or supplemented by a signed writing.


