**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This Release of Security Interests in Trademarks (this “Release”) is made this 23rd day of December, 2014 (“Effective Date”) by and between FCA, LLC, a Delaware limited liability company (“Grantor”), and Fidus Mezzanine Capital II, L.P., a Delaware limited partnership (“Grantee”).

WHEREAS, pursuant to the terms and conditions of that certain Senior Subordinated Loan and Security Agreement by and between Grantor and Grantee dated June 18, 2013 (the “Security Agreement”), Grantor granted to Grantee a continuing security interest in and to all of Grantor’s right, title and interest in and to all of the trademarks, and the resulting United States trademark registrations therefor, set forth on Schedule A attached hereto (collectively, the “Trademarks”), together with the goodwill associated therewith;

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office (“PTO”) on June 18, 2013, at Reel 5050, Frame 0248; and

WHEREAS, Grantor has paid all of its outstanding indebtedness to Grantee concerning the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademarks.

At the sole expense of Grantor, Grantee shall take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.


