## Minutes of the Annual Meeting of Directors of The Learning Key, Inc.

The annual meeting of directors and shareholders of the corporation was held via a phone teleconference between Albuquerque, NM and Cotton, MN on December 12, 2013 at 2:00 P.M.

The following were in attendance: Elizabeth Treher, Janet Noah, In Albuquerque, and Jack Treher in Cotton, being a quorum and all of the directors of the corporation and representing one hundred percent of the shareholders of the corporation.

Elizabeth Treher is elected Chairman of the meeting, Janet Noah is appointed Corporate Secretary, and Jack Treher is appointed Corporate Treasurer.

The directors discussed the status of the company - and its financial status. The company will likely be closed, pending evaluation by the accountant replacing Don Sorensen who retired. In the interim, It was agreed that Elizabeth Treher may buy the intellectual property remaining - name, copyrights/TMs, product designs, website and domain name for the sum of \$1000 - to be paid by reducing the debt owed her by The Learning Key, Inc.

Janet Noah resigned from the company, effective December 31, 2013 and will return her shares of stock for \$1. There being no further business, upon motion duly made and seconded, the meeting was adjourned.
