**RELEASE AND TERMINATION OF SECURITY INTEREST  
IN TRADEMARKS**

This RELEASE and TERMINATION is made by KEYBANK NATIONAL ASSOCIATION (as successor in interest to AMERITRUST COMPANY NATIONAL ASSOCIATION), \_\_\_\_\_, Cleveland, OH \_\_\_\_\_ (hereinafter "KEYBANK").

WHEREAS, Commercial and Architectural Products, Inc. (now known as Marlite, Inc.) ("Pledgor") and KEYBANK (as successor to AmeriTrust) entered into a Trademark Security Agreement (the "Security Agreement") on January 27, 1989 and recorded in the U.S. Patent and Trademark Office on February 9, 1989, at Reel 640 Frame 0002, in which Security Agreement the Pledgor granted a security interest to KEYBANK in certain Trademarks that the Pledgor then owned.
