DEED OF TRANSFER

This DEED OF TRANSFER of the trademark and the registration thereof listed on Schedule A attached hereto (the "Deed"), dated as of January 1, 2015 is by and among Setterstix Corporation, a Delaware corporation (the "Assignor"), and Setter US Inc., a Delaware corporation (the "Assignee").

RECITALS

A. Assignor owns right, title, and interest in and to the trademark and the registrations thereof listed on Schedule A attached hereto (the "Trademark").

B. Assignor wishes to sell, transfer, assign and convey to Assignee, and Assignee wishes to acquire, the Trademark.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are acknowledged, Assignor hereby grants, conveys and assigns to Assignee all of Assignor's right, title, and interest in and to the Trademark and registrations thereof, together with (i) all income, royalties, damages and payments now and later due and payable with respect to the Trademark, including, without limitations, damages and payments now and later for past, present or future infringements; (ii) the right to sue for past, present and future infringements; (iii) all rights to such Trademark; and (iv) the good will of the business associated with and symbolized by the Trademark and registrations. Assignor covenants that it shall execute any other documents and perform any other acts that may be reasonably necessary fully to vest in Assignee the rights conveyed by this Deed. Nothing in this Deed shall be deemed to modify, amend or alter any of the representations, warranties and covenants contained in the Asset Purchase Agreement, dated as of January 1, 2015, of which the Assignor and the Assignee are, among others, parties, all of which survive to the extent set forth under such Asset Purchase Agreement, the execution and delivery of this Deed. This Deed shall be binding upon Assignor, its successors and assigns, and shall inure to the benefit of Assignee, its successors and assigns. This deed shall be governed by and construed in accordance with the law of the State of New York (without giving effect to conflicts of law principles thereof) and, where appropriate, applicable federal law.

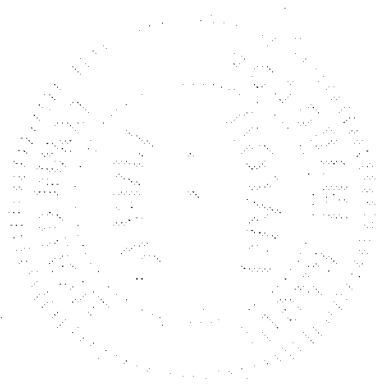
