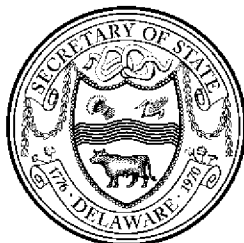



The undersigned, on behalf of Marathon Data Operating Co., LLC, a limited liability company duly organized and existing under and by virtue of the laws of the State of Delaware (the "Company"), desiring to merge Vantage Point Mapping, Inc., a Missouri corporation ("Vantage Point"), with and into itself, pursuant to the provisions of Section 18-209 of the Limited Liability Company Act of the State of Delaware, DOES HEREBY CERTIFY as follows:

**FIRST:** The name and state of formation of each constituent entity of the merger (the "Merger") are as follows: (i) Vantage Point Mapping, Inc., a Missouri corporation, and (ii) Marathon Data Operating Co., LLC, a Delaware limited liability company.


**FIFTH:** A copy of the Merger Agreement will be furnished by the Surviving Company, upon request and without cost, to any member or shareholder of the constituent entities.
