FURTHER RESOLVED, that the Articles of Incorporation of the corporation be amended to state the address of the corporation as follows:

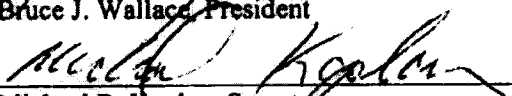
The location and address of this corporation's registered office in this state shall be 3400 Sycamore Lane N., Plymouth, MN 55441.
