**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of January 6, 2015 (the "*Termination and Release*"), is made from Square 1 Bank ("*Square 1*"), to GenMark Diagnostics, Inc. (as successor-in-interest to Clinical Micro Sensors, Inc.) ("*Grantor*").

WITNESSETH:

WHEREAS, in connection with certain financing arrangements among, inter alia, Square 1 and Grantor, Grantor granted a security interest (the "*Security Interest*") in the trademarks listed on Schedule 1 hereto and related ancillary rights (the "*Trademark Collateral*") to Square 1;


