**FIRST AMENDMENT TO PATENT, TRADEMARK, COPYRIGHT AND LICENSE
MORTGAGE**

THIS FIRST AMENDMENT TO PATENT, TRADEMARK, COPYRIGHT AND LICENSE MORTGAGE (this "Amendment") is made as of this 7th day of January, 2015, by Stampede Meat, Inc., a Delaware corporation, with its principal place of business and chief executive office at 7351 South 78th Avenue, Bridgeview, Illinois 60455 ("Mortgagor"), in favor of Wells Fargo Capital Finance, LLC, as Agent, with an office at 10 South Wacker Drive, Suite 1300, Chicago, Illinois 60606 ("Mortgagee");

W I T N E S S E T H

WHEREAS, Mortgagor and Mortgagee entered into that certain Patent, Trademark, Copyright and License Mortgage dated as of January 8, 2009 (as amended, restated, supplemented, or otherwise modified from time to time, the "Mortgage");

WHEREAS, the Mortgage was duly recorded in the United States Patent and Trademark Office on January 13, 2009, Reel/Frame: 003917/0845;

WHEREAS, since the date of the Mortgagor's execution of the Mortgage, Mortgagor has acquired interests in certain additional Trademarks, all of which are listed on Schedule A hereto (the "New Trademarks"); and

WHEREAS, in accordance with Section 5 of the Mortgage, the parties hereto agree to amend the Mortgage to confirm the inclusion of such New Trademarks;


NOW, THEREFORE, for good and valuable consideration, the receipt and legal sufficiency of which are hereby acknowledged, the parties hereto hereby agree to amend the Mortgage as follows:

1. Definitions. All capitalized terms used herein but not otherwise defined herein shall have the meanings ascribed to them in the Mortgage.
2. Security Interest in New Trademarks. To secure the Secured Obligations, Mortgagor hereby grants and pledges to Mortgagee, for the benefit of the Lenders, and hereby reaffirms its prior grant pursuant to the Loan and Security Agreement and the Mortgage of, a continuing security interest in such Mortgagor's right, title and interest in and to the Trademarks, whether now owned or hereafter acquired or arising, including the New Trademarks.
3. Supplemented Schedule A. Exhibit B of the Mortgage is hereby supplemented to add the New Trademarks.
4. Effect of Amendment. Except as expressly amended by this Amendment, the terms of the Mortgage shall remain in full force and effect as executed.
