TRADEMARK ASSIGNMENT AGREEMENT**

This TRADEMARK ASSIGNMENT AGREEMENT is made, entered into and effective this 25th day of November 2014 (the "*Effective Date*"), by and among F5 Networks, Inc., a Washington corporation, with principal place of business at 401 Elliott Ave. West, Seattle, WA 98119 ("*Assignee*") and LYATISS SAS, a French corporation, having its principal place of business at 39, rue du Mail, 69004 Lyon, France ("*Assignor*").

WHEREAS, Assignor agreed to sell, assign, transfer, convey and deliver to Assignee certain Intellectual Property as defined and described in the Intellectual Property Purchase Agreement between Assignor and Assignee, dated as of as of November 25, 2014 (the "*Purchase Agreement*");

WHEREAS, Assignor, has existing trademark registrations, pending applications, and common law rights in the marks that are the subject of this assignment and is the owner of the marks set forth in Exhibit A to the purchase Agreement ("*Marks*"), which Exhibit is incorporated herein by reference;

WHEREAS, Assignee, is desirous of acquiring said Marks and any and all goodwill associated therewith;

NOW THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor does hereby assign unto Assignee all right, title and interest in and to the Marks set forth in Exhibit A, together with that portion of its business relating to the marks and the goodwill appurtenant thereto. Assignor shall execute and deliver such instruments and take such other action as may be requested by Assignee to perfect or protect Assignee's rights in the Marks and to carry out the assignments effected by this Agreement, and assist Assignee and its nominees in every proper way to secure, maintain, protect and defend for Assignee's own benefit all such rights in the Marks in any and all countries. Assignor shall cooperate with Assignee in the filing and prosecution (at Assignee's sole expense) of any trademark applications or related supplemental filings or petitions that Assignee may elect to file.


