NICK MALDONADO and OSCAR TORO, Individuals, and as Managers of TORO TAX FRANCHISING LLC, a Nevada limited liability company, being first duly sworn upon oath, state as follows:

1. **Agreement:** NICK MALDONADO and OSCAR TORO executed that Agreement entitled TRADEMARK ASSIGNMENT AGREEMENT November 25th, 2014 (“Agreement”).
2. **Assignors:** The Assignors are NICK MALDONADO and OSCAR TORO, Individuals.
3. **Assignee:** TORO TAX FRANCHISING LLC, a Nevada limited liability company.
4. **Mark:** Assignors have assigned the Mark application “**TORO TAXES**” identified as **USPTO Serial No.: 86360745, Application Filing Date: August 7, 2014** (the “**Mark**”) and more fully described on Exhibit A attached hereto and made a part hereof.
5. **Assignment:** Assignors do hereby irrevocably assign to Assignee, and Assignee hereby accepts from Assignors, all rights, title, and interest (including, but not limited to, all registration rights with respect to the Mark, all rights to prepare derivative marks, all goodwill and all other rights), in and to the Mark.
6. **Consideration:** The consideration for the Mark is specified in the Agreement.
7. **Representations and Warranties.** Assignors represent and warrant to Assignee:
 - i. Assignors have the right, power and authority to enter into this Agreement;
 - ii. Assignors are the exclusive owners of all right, title and interest, including all intellectual property rights, in the Mark;
 - iii. The Mark is free of any liens, security interests, encumbrances or licenses;

- iv. Assignors have not licensed the Mark to any other person or entity or granted, either expressly or impliedly, any trademark or servicemark rights with respect to the Mark to any other person or entity;
 - v. There are no claims, pending or threatened, with respect to Assignors' rights in the Mark;
 - vi. This Agreement is valid, binding and enforceable in accordance with its terms in all jurisdictions pertaining hereto; and
 - vii. Assignors are not subject to any agreement, judgment or order inconsistent with the terms of this Agreement.
8. **Use of Mark.** After the Effective Date, Assignors agree to make no further use of the Mark or any mark confusingly similar thereto, anywhere in the world, except as may be expressly authorized by the parties in writing and Assignors agrees to not challenge Assignee's use or ownership or the validity of the Mark.
9. **Attorneys' Fees.** Should either party hereto, or any heir, personal representative, successor or assign of either party hereto, resort to litigation to enforce this Agreement, the party prevailing in such litigation shall be entitled, in addition to such other relief as may be granted, to recover its or their reasonable attorneys' fees and costs (including all court costs) in such litigation from the party against whom enforcement was sought.
10. **Entire Agreement.** This Agreement, contains the entire understanding and agreement between the parties hereto with respect to its subject matter and supersedes any prior or contemporaneous written or oral agreements, representations or warranties between them respecting the subject matter hereof. There are no amendments, exhibits, or additional terms.
11. **Binding Agreement.** This Agreement shall be binding on and shall inure to the benefit of the parties to this Agreement and their successors and assigns, if any.
12. **Amendment.** This Agreement may be amended only by a written agreement signed by both parties which explicitly adjoins itself to this Agreement.
13. **Severability.** If any term, provision, covenant or condition of this Agreement, or the application thereof to any person, place or circumstance, shall be held by a court of competent jurisdiction to be invalid, unenforceable or void, the remainder

of this Agreement and such term, provision, covenant or condition as applied to other persons, places and circumstances shall remain in full force and effect, except as mandated by the ruling.

14. **Agreement to Perform Necessary Acts.** Assignee agrees to perform any further acts and execute and deliver any documents that may be reasonably necessary to carry out the provisions of this Agreement.

15. **Governing Law.** This Agreement shall be construed in accordance with, and all actions arising hereunder shall be governed by, the laws of the State of Nevada.

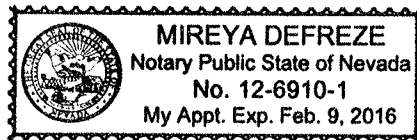
