NOW, THEREFORE, the parties agree as follows:



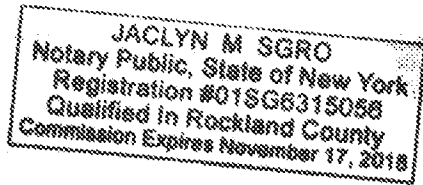


