## Grant of Security Interest in United States Trademarks

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and sufficiency of which are hereby acknowledged, CATALYST PAPER OPERATIONS INC., a corporation duly organized and existing under the laws of the State of Delaware (the "Grantor"), hereby grants to COMPUTERSHARE TRUST COMPANY OF CANADA, as Collateral Trustee, (the "Grantee"), a security interest in all of Grantor's right, title and interest in, to and under the following:

(i) each United States trademark registration and trademark application set forth on **Schedule A** hereto and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark registration and trademark application (collectively, the "Trademarks"); and

(ii) all proceeds of the foregoing, including any claim by the Grantor against third parties for past, present or future infringement or dilution or other violation of any Trademark, or for injury to the goodwill associated with any Trademark.

THIS GRANT is granted in conjunction with the security interests granted to the Grantee pursuant to (x) the Security Agreement among the Grantor, the Grantee and certain other parties thereto, dated as of September 13, 2012, as amended, restated, amended and restated, modified or supplemented from time to time (the "2012 Security Agreement") and (y) the Security Agreement among the Grantor, the Grantee and certain other parties thereto, dated as of March 20, 2014, as amended, restated, amended and restated, modified or supplemented from time to time (the "2014 Security Agreement" and together with the 2012 Security Agreement, collectively, the "Security Agreement"), and is expressly subject to the terms and conditions thereof. The rights and remedies of the Grantee with respect to the security interest granted herein are more fully set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Agreement are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.
