1. The name of the corporation is: Billups Worldwide, Inc.

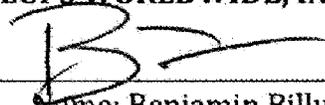
Pursuant to ORS 60.437, Article 1 shall reflect the name of the corporation to be Billups, Inc.
