**AMENDED AND RESTATED**  
**PATENT AND TRADEMARK SECURITY AGREEMENT**

THIS AMENDED AND RESTATED PATENT AND TRADEMARK SECURITY AGREEMENT (this "Agreement"), dated as of November 13, 2014, by SCOTT ARCHERY LLC, a Delaware limited liability company ("Scott"), CBE ARCHERY LLC, a Delaware limited liability company ("CBE"), ELITE OUTDOORS LLC, a Delaware limited liability company, ("Elite"), PERFECT FORM MANUFACTURING LLC, a Delaware limited liability company ("Perfect"), OUTDOOR GROUP GAME CALLS LLC, a Delaware limited liability company ("Game"), WINNER'S CHOICE BOWSTRINGS LLC, a Delaware limited liability company ("Bowstrings"), SLICK TRICK LLC, a Delaware limited liability company ("Slick"), (Scott, CBE, Elite, Perfect, Game, Bowstrings, and Slick each a "Grantor" and collectively, the "Grantors"), each of which has its chief executive office at 235 Middle Road, Henrietta, New York 14467, in favor of FIRST BANK & TRUST, an Illinois state bank (the "Bank"), whose address is 820 Church Street, Evanston, Illinois 60201 ("Lender").

**RECITALS**

A. The Lender has previously made certain loans (the "Prior Loans") to Scott, CBE, The Outdoor Group, LLC, a Delaware limited liability company, Elite, Perfect, All American Precision Tool & Mold Co., Inc., a New York corporation, Game, Bowstrings, and Solid Broadhead LLC, a Delaware limited liability company (each and collectively, the "Original Borrower").

B. As a condition precedent to the Lender's extension of the Prior Loans to the Original Borrower and in consideration therefor, the Lender required the execution and delivery of (i) that certain Patent and Trademark Security Agreement dated as of March 7, 2012 given by Scott in favor of Lender, (ii) that certain Patent and Security Agreement dated as of December 18, 2012 given by Game in favor of Lender, (iii) that certain Patent and Trademark Security Agreement dated December 18, 2012 given by Bowstrings in favor of Lender, (iv) that certain Patent and Trademark Security Agreement dated December 24, 2013 given by Scott in favor of Lender, and (v) that certain Patent and Trademark Security Agreement dated December 24, 2013 given by Perfect in favor of Lender (collectively, the "Original Security Agreements"), and (iv) those certain documents (the "Prior Loan Documents") set forth on Exhibit A attached hereto and made a part hereof.

C. Original Borrower, Slick (the Original Borrower and Slick are hereinafter each and collectively referred to as the "Borrower"), and Guarantor have now requested that Lender amend the Prior Loan Documents in order to, among other things, add Slick as a Borrower under Loan (as hereinafter defined and consolidate the Prior Loans into (i) a Revolving Loan in an amount not to exceed Six Million and 00/100 Dollars (\$6,000,000.00) outstanding at any one time (the "Revolving Loan") and (ii) that certain Term Loan in the principal amount of Eleven Million and 00/100 Dollars (\$11,000,000.00) (the "Term Loan") (the Revolving Loan and Term Loan are hereinafter each and collectively referred to as the "Loan").

D. As a condition precedent to Lender's agreement to consolidate the Prior Loans into the Loan as provided in that certain Amended and Restated Loan and Security Agreement dated as of even date herewith (the "Loan Agreement"; all terms not otherwise defined herein shall have the meanings given them in the Loan Agreement) among Borrower, Guarantor and Lender, Lender has required the execution and delivery by Guarantor of this Amended Guaranty.

E. Pursuant to the Loan Agreement, Borrower is delivering to Lender, among other things, (i) that certain Fourth Amended and Restated Revolving Note dated as of even date herewith (the "Revolving Note") in an amount not to exceed Six Million and 00/100 Dollars (\$6,000,000.00) outstanding at any one time, and (ii) that certain Amended and Restated Term Note dated as of even date herewith (the "Term Note") in the principal amount of Eleven Million and 00/100 Dollars (\$11,000,000.00) (the Revolving Note and the Term Note are hereinafter collectively referred to as the "Note"). The Loan Agreement, the Security Documents, the Note, and every other document evidencing or securing the Loan are hereinafter collectively referred to as the "Loan Documents".

F. Pursuant to the Loan Agreement, Grantor is required to execute and deliver this Agreement to the Lender in order to grant to the Lender a security interest in substantially all the assets of the Grantor, including all right, title and interest of the Grantor in, to and under all now owned and hereafter acquired patents, patent applications, patent licenses, trademarks, trademark registrations, trademark applications and trademark licenses, and all products and proceeds thereof, to secure the payment of all amounts owing by the Grantor under the Loan Agreement.

G. This Agreement amends, restates and replaces each of the Original Security Agreements in their entirety.

#### AGREEMENTS

In consideration of the mutual agreements set forth herein and in the Loan Agreement, the Grantor does hereby grant to Lender, a continuing security interest in all of Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter created or acquired:

- (1) each trademark, trademark registration and trademark application, including, without limitation, each trademark, trademark registration and trademark application referred to in Schedule 1 annexed hereto, together with any reissues, continuations or extensions thereof and all goodwill associated therewith;
- (2) each trademark license, including, without limitation, each trademark license listed on Schedule 1 annexed hereto, together with all goodwill associated therewith;
- (3) all products and proceeds of the foregoing, including, without limitation, any claim by the Grantor against third parties for past, present or future infringement of any trademark, including, without limitation, any trademark referred to in Schedule 1 annexed hereto, any trademark registration issued pursuant to a trademark application referred to in Schedule 1 and any trademark licensed under

any trademark license listed on Schedule 1 annexed hereto (items 1 through 3 being herein collectively referred to as the "Trademark Collateral");

- (4) each patent and patent application, including, without limitation, each patent and patent application referred to in Schedule 2 annexed hereto, together with any reissues, continuations or extensions thereof and all goodwill associated therewith;
- (5) each patent license, including, without limitation, each patent license listed on Schedule 2 annexed hereto, together with all goodwill associated therewith;
- (6) all products and proceeds of the foregoing, including, without limitation, any claim by the Grantor against third parties for past, present or future infringement of any patent, including, without limitation, any patent referred to in Schedule 2 annexed hereto, any patent issued pursuant to a patent application referred to in Schedule 2 and any patent licensed under any patent license listed on Schedule 2 annexed hereto (items 4 through 6 being herein collectively referred to as the "Patent Collateral").


