## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Release"), effective as of this 9<sup>th</sup> day of January, 2015, is made by **SUNTRUST BANK**, a Georgia bank, with an address at 211 Perimeter Center Parkway, Suite 100, Atlanta, Georgia 30346, as administrative agent (in such capacity, together with its successors and permitted assigns, the ("Administrative Agent") for the Lenders in favor of Halifax Worcester, LLC, a Florida limited liability company ("Grantor"), as follows:

### W I T N E S S E T H

WHEREAS, the Grantors and the Administrative Agent are party to that certain Revolving Credit and Term Loan Agreement dated as of October 10, 2013 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement");

WHEREAS, in connection with the Credit Agreement, the Grantor executed that certain Security Agreement, dated as of October 10, 2013 (as amended, supplemented or otherwise modified from time to time, the "Security Agreement"), and granted to the Administrative Agent a security interest in and to all Grantor's right, title and interest in all United States trademarks, trademark registrations and trademark applications and any renewals thereof, including as set forth on Schedule A attached hereto (collectively, the "Trademarks") to secure the Obligations (as defined in the Credit Agreement);

WHEREAS, in furtherance of the Security Agreement, the Grantor executed a Trademark Security Agreement, dated June 2, 2014 (the "Trademark Security Agreement"), which was duly recorded on July 14, 2014, at Reel/Frame 5321/0682 in the United States Patent and Trademark Office;


WHEREAS, the Administrative Agent wishes to release and restore all right, title and interest in and to the Trademarks to the Grantor and to dissolve those liens and encumbrances created by the Trademark Security Agreement and the Security Agreement in respect of the Trademarks.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Administrative Agent hereby grants, assigns and conveys, without recourse or warranty, to the Grantor all of its rights, title and interest in the Trademarks, and terminates, releases, discharges, quitclaims and relinquishes unto the Grantor any and all security interests and liens it has against the Trademarks.
