## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Release") is made as of this 31 day of December 2014, by WELLS FARGO CAPITAL FINANCE CORPORATION CANADA, in its capacity as agent ("Agent"), in favor of COMPLETE INNOVATIONS INC., an Ontario corporation ("Company").

WHEREAS, Company and Agent entered into that certain US Trademark Security Agreement dated October 31, 2014 ("Trademark Security Agreement"), whereby Company granted Agent a security interest in all of its right, title, and interest in, to and under: (i) all of its trademarks including those referred to in Schedule A attached hereto; (ii) all goodwill of the business connected with the use of, and symbolized by, each trademark; and (iii) all products and proceeds (as that term is defined in the UCC) of the foregoing, including any claim by Company against third parties for past, present, or future (a) infringement or dilution of any trademark, including right to receive any damages, or (b) injury to the goodwill associated with any trademark (collectively, the "Trademark Collateral"); and

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on November 3, 2014 at Reel 5392, Frame 0433.


NOW, THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Agent hereby (i) terminates the Trademark Security Agreement and unconditionally and expressly releases, terminates, and extinguishes its liens on and security interests in the Trademark Collateral; and (ii) authorizes and requests that the United States Patent and Trademark Office note and record the release hereby given and any other filings necessary to evidence the release and termination of the Agent's rights under the Trademark Security Agreement with respect to the Trademark Collateral.

Agent consents and agrees to execute and deliver, at the request and cost of Company, such further instruments, documents and release forms as Company may reasonably request to more effectively release, terminate and extinguish any such liens and security interests upon such trademarks.
