RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST

This RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST ("Release"), is made and effective as of March 3, 2014 and granted by WELLS FARGO CAPITAL FINANCE, LLC (formerly known as Wells Fargo Foothill, LLC), a Delaware limited liability company ("Wells Fargo"), located at 2450 Colorado Avenue, Suite 3000, Santa Monica CA 90404, as agent (in such capacity, the "Agent") for the Lenders that are signatories to the Credit Agreement referred to below and the Bank Product Providers (collectively, the "Secured Parties"), in favor of STREAM INTERNATIONAL INC., a Delaware corporation, and its successors, legal representatives and assignees (collectively, the "Grantor").

WHEREAS, Stream Global Services, Inc., a Delaware Corporation ("Parent"), entered into a Credit Agreement dated as of October 1, 2009 (as amended, restated, supplemented, or otherwise modified from time to time, the "Credit Agreement"; capitalized terms used herein without definition having the meanings ascribed thereto in the Credit Agreement or the Security Agreement referred to below, as applicable), by and among Parent, each of Parent's Subsidiaries from time to time party thereto, the lenders party thereto (such lenders, together with their respective successors and assigns in such capacity, the "Lenders") and Wells Fargo, as Agent;

WHEREAS, in connection with the Credit Agreement, the Grantor entered into (a) the Security Agreement dated as of October 1, 2009 (as amended, restated, supplemented, or otherwise modified from time to time, the "Security Agreement"), by and among Parent, each of its Parent's Subsidiaries from time to time party thereto (including the Grantor) and Wells Fargo, as Agent, (b) the Patent Security Agreement dated as of October 1, 2009 (as amended, restated, supplemented, or otherwise modified from time to time, the "Patent Security Agreement"), between the Grantor and Wells Fargo, as Agent, and (c) the Trademark Security Agreement dated as of October 1, 2009 (as amended, restated, supplemented, or otherwise modified from time to time, the "Trademark Security Agreement" and, together with the Security Agreement and the Patent Security Agreement, the "Security Agreements"), between the Grantor and Wells Fargo, as Agent;

WHEREAS, the Grantor has pledged and granted to the Agent for the ratable benefit of the Secured Parties (the "Grant of Security Interest"), a security interest in and to all of the right, title and interest of such Grantor in, to and under (a) the Patent Collateral (as defined in the Patent Security Agreement), including the Patent Collateral listed on Schedule 1 attached hereto, and (b) the Trademark Collateral (as defined in the Trademark Security Agreement), including the Trademark Collateral listed on Schedule 2 attached hereto (the intellectual property described in clauses (a) and (b) being collectively referred to herein as the "IP Collateral");

WHEREAS, the Trademark Security Agreement was recorded in the records of the United States Patent and Trademark Office (the "USPTO") beginning at Reel 4071/Frame 0759 on October 1, 2009, and the Patent Security Agreement was recorded in the records of the USPTO beginning at Reel 023312/Frame 0504 on October 1, 2009;

WHEREAS, the Grantor has requested that the Agent enter into this Release in order to accomplish and evidence the release and reassignment of any and all right, title and interest the Agent and the Secured Parties may have in the IP Collateral pursuant to the Security Agreements; and

WHEREAS, the Agent wishes to release and reassign all of the right, title and interest of the Agent and the Secured Parties in the IP Collateral and record such release and reassignment in the records of the USPTO.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates, releases and discharges fully its security interest in and lien on the IP Collateral as granted pursuant to the Grant of Security Interest, and the Agent reconveys, transfers, and assigns to Grantor, as applicable, without recourse, representation or warranty of any kind, any right, title and interest it may have in the IP Collateral pursuant to or in connection with the Grant of Security Interest and any right, title or interest of the Agent shall hereby cease and become void.
