This Assignment is binding upon, will inure to the benefit of and shall be enforceable by each of the parties hereto and their respective successors and assigns and may be executed in two or more counterparts (including by means of facsimile and/or electronic transmission), each of which will be deemed an original but all of which together constitute but one and the same instrument.

3. Assignor and Assignee may amend, modify and supplement this Assignment in such manner as may be mutually agreed by them in writing.



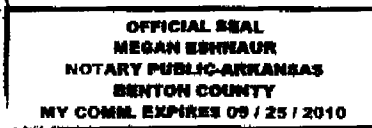


