NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN:



Assignor will have a wind-down period of thirty (30) days after the Effective Date to permit its former licensee, Car Credit City, LLC, to

discontinue use of the Mark. After the wind-down period, Assignor will not use or permit others to use the Mark or any mark that is substantially similar thereto.
