## **RELEASE OF FIRST LIEN SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF FIRST LIEN SECURITY INTEREST IN TRADEMARKS, dated as of December 22, 2014 ("Release"), is made by BANK OF THE WEST, a California banking corporation located at 1036 State Street, Santa Barbara, California 93102, in its capacity as collateral agent pursuant to the First Lien Credit Agreement (in such capacity, the "Collateral Agent"), in favor of ABLEST LLC (f/k/a ABLEST INC.), a Delaware corporation located at 3820 State Street, Santa Barbara, California 93105, KOOSHAREM LLC (f/k/a KOOSHAREM CORPORATION), a California corporation located at 3820 State Street, Santa Barbara, California 93105, REMEDYTEMP, LLC (f/k/a REMEDYTEMP, INC.), a California corporation located at 3820 State Street, Santa Barbara, California 93105, REMX, LLC (f/k/a REMX, INC.), a California corporation located at 3820 State Street, Santa Barbara, California 93105, SELECT TEMPORARIES, LLC (f/k/a SELECT TEMPORARIES, INC.), a California corporation located at 3820 State Street, Santa Barbara, California 93105, TANDEM STAFFING SOLUTIONS, LLC (f/k/a TANDEM STAFFING SOLUTIONS, INC.), a Delaware corporation located at 3820 State Street, Santa Barbara, California 93105, and WESTAFF SUPPORT, INC., a California corporation located at 3820 State Street, Santa Barbara, California 93105 (individually, a "Grantor," and collectively, the "Grantors"). Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the meaning given to them in the Security Agreement.

### **WITNESSETH:**

WHEREAS, the Grantors are party to a First Lien Pledge and Security Agreement, dated as of July 12, 2007 (the "Security Agreement"), in favor of the Collateral Agent, pursuant to which each Grantor was required to execute and deliver a First Lien Trademark Security Agreement;

WHEREAS, reference is made to the First Lien Trademark Security Agreement, dated as of July 12, 2007, by ABLEST LLC; First Lien Trademark Security Agreement, dated as of July 12, 2007, by KOOSHAREM LLC; First Lien Trademark Security Agreement, dated as of July 12, 2007, by REMEDYTEMP, LLC; First Lien Trademark Security Agreement, dated as of July 12, 2007, by REMX, LLC; First Lien Trademark Security Agreement, dated as of July 12, 2007, by SELECT TEMPORARIES, LLC; First Lien Trademark Security Agreement, dated as of October 1, 2007, by TANDEM STAFFING SOLUTIONS, LLC; and First Lien Trademark Security Agreement, dated as of March 18, 2009, by WESTAFF SUPPORT, INC. (each, a "Trademark Security Agreement" and collectively, the "Trademark Security Agreements") by the Grantors in favor of the Collateral Agent;

WHEREAS, pursuant to the respective Trademark Security Agreement, each Grantor pledged and granted to the Collateral Agent for the benefit of the Secured Parties a lien on and security interest in and to all of its right, title and interest in, to and under all Trademarks of such Grantor listed on Schedule I attached hereto (collectively, the "Trademark Collateral");

WHEREAS, the Trademark Security Agreements were recorded by the United States Patent and Trademark Office (the "PTO") on the following dates and appears at the following location in the PTO records:

April 22, 2009, at 3974/Frame 0530 (WESTAFF SUPPORT, INC.); and

WHEREAS, the Collateral Agent has agreed to terminate, discharge and release its lien on and security interest in the Trademark Collateral and reassign and transfer all of its right, title and interest in the Trademark Collateral to the Grantors, respectively.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:


1. Release of Lien. The Collateral Agent hereby terminates each Trademark Security Agreement (other than any provisions which by their terms survive termination), and hereby terminates, discharges and releases any and all liens on and security interests it has in, to and under the Trademark Collateral of each Grantor. The Collateral Agent hereby reassigns and transfers to the Grantors, respectively, without any representation, warranty, recourse or undertaking by the Collateral Agent, any right, title or interest that the Collateral Agent may have in the Trademark Collateral. The Collateral Agent is providing no representation or warranty as to the accuracy of the recitals to this Agreement of the Schedules attached hereto.

2. Authorization to Record. The Collateral Agent authorizes and requests that the United States Patent and Trademark Office and any other applicable government officer record this Release.

3. Further Assurances. The Collateral Agent shall take all further actions, and provide to the Grantors, their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors to more fully and effectively effectuate the purposes of this Release, in each case at the expense of the Grantors.
