Cornerstone Therapeutics Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation"), hereby certifies as follows:

1. The name of the Corporation is Cornerstone Therapeutics Inc. The amended and restated Certificate of Incorporation of the Corporation was filed in the State of Delaware on February 3, 2014 (the "Certificate of Incorporation").

2. The Board of Directors of the Corporation pursuant to Section 242 of the General Corporation Law duly adopted a resolution setting forth a proposed amendment to the Certificate of Incorporation and declaring such amendment advisable. The stockholders of the Corporation pursuant to Section 242 of the General Corporation Law duly approved and adopted such proposed amendment by written consent in lieu of a special meeting of stockholders pursuant to Section 228 of the General Corporation Law. Accordingly, to effect such amendment, the Certificate of Incorporation shall be amended by deleting the existing first sentence of Article 1 in its entirety and inserting the sentence set forth below in lieu thereof:
