TRADEMARK SECURITY AGREEMENT, dated as of January 14, 2015, by and among the subsidiaries of Holdings (as defined below) party hereto and BANK OF AMERICA, N.A., as Collateral Agent.

Reference is made to the Guarantee and Collateral Agreement dated as of October 18, 2013 (as amended, supplemented or otherwise modified from time to time, including but not limited to, by those certain Assumption Agreements, dated as of September 15, 2014 and November 21, 2014, the "Security Agreement"), among Scientific Games International, Inc., a Delaware corporation (the "Borrower"), Scientific Games Corporation, a Delaware corporation ("Holdings"), the subsidiaries of Holdings party thereto and the Collateral Agent (as defined below). The Lenders (as defined below) have agreed to extend credit to the Borrower subject to the terms and conditions set forth in the Credit Agreement dated as of October 18, 2013 (as it may be amended, waived, supplemented or otherwise modified, including but not limited to, by that certain Amendment No. 1 dated as of October 1, 2014, among the Borrower, Holdings, the other subsidiaries of Holdings party thereto, the Lenders and Bank of America, N.A., as Administrative Agent, Collateral Agent (in such capacity, the "Collateral Agent"), the "Credit Agreement") among the Borrower, Holdings, the lenders from time to time party thereto (the "Lenders"), Bank of America, N.A., as Administrative Agent, Collateral Agent, Issuing Lender and Swingline Lender, and the other banks and financial institutions party thereto. The subsidiaries of Holdings party hereto (collectively, the "Debtor") are engaged in related businesses, and the Debtor will derive substantial benefits from the extension of credit to the Borrower pursuant to the Credit Agreement. Accordingly, the parties hereto agree as follows:

SECTION 1. Terms. Capitalized terms used in this Agreement and not otherwise defined herein have the meanings specified in the Security Agreement. The rules of construction specified in Section 1.2 of the Security Agreement also apply to this Agreement.

SECTION 2. Grant of Security Interest. As security for the payment or performance, as the case may be, in full of the Obligations, the Debtor, pursuant to the Security Agreement, did and hereby does grant to the Collateral Agent, its successors and assigns, for the benefit of the Secured Parties, a security interest in, all right, title or interest in or to any and all of the following assets and properties now owned or at any time hereafter acquired by such Debtor or in which such Debtor now has or at any time in the future may acquire any right, title or interest (collectively, the "Trademark Collateral"):


(i) all trademarks, trade names, corporate names, company names, business names, domain names, fictitious business names, trade dress, trade styles, service marks, logos and other source or business identifiers, designs and general intangibles of like nature, and all goodwill associated therewith or symbolized thereby, all registrations and recordings thereof, and all applications in connection therewith (except for "intent to use" applications for trademark or service mark registrations filed pursuant to Section 1(b) of the Lanham Act, 15 U.S.C. § 1051, unless and until an Amendment to Allege Use or a Statement of Use under Section 1(c) or 1(d) of said Act has been filed), whether in the United States Patent and Trademark Office or in any similar office or agency of the United States or any State thereof, and all United States common-law rights related thereto owned

by such Debtor in its own name, including, without limitation, any of the foregoing referred to in Schedule I and (ii) the right to obtain all renewals thereof.

SECTION 3. Security Agreement. The security interests granted to the Collateral Agent herein are granted in furtherance, and not in limitation of, the security interests granted to the Collateral Agent pursuant to the Security Agreement. The Debtor hereby acknowledges and affirms that the rights and remedies of the Collateral Agent with respect to the Trademark Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the Security Agreement, the terms of the Security Agreement shall govern.




