INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (this “**Assignment**”), is made as of July 10, 2014 (the “**Effective Date**”), by and among Medicis Pharmaceutical Corporation, a corporation organized and existing under the laws of the state of Delaware, Valeant Pharmaceuticals North America LLC, a limited liability company organized and existing under the laws of the state of Delaware, Valeant International Bermuda, a corporation organized and existing under the laws of Bermuda, Valeant Pharmaceuticals International, Inc., a corporation continued under the laws of the province of British Columbia, and Valeant Pharmaceuticals International, a corporation organized under the laws of the state of Delaware (each of the foregoing, an “**Assignor**” and, collectively, the “**Assignors**”), and Galderma, S.A., a corporation organized and existing under the laws of Switzerland (“**Galderma**” or “**Assignee**”).

WHEREAS, the Sellers and Nestlé S.A. have entered into that certain Asset Purchase Agreement, dated as of May 27, 2014 (the “**Purchase Agreement**”), pursuant to which Sellers agreed, on behalf of themselves and their Affiliates, to sell, convey, assign, transfer and deliver to Nestlé S.A. (or one or more of its Affiliates) all of their rights, title and interest in and to the Acquired Intellectual Property Rights (as defined in the Purchase Agreement), including, without limitation, the Intellectual Property (as defined in the Purchase Agreement) set forth on Schedule A hereto (the “**Scheduled Intellectual Property Rights**”);

WHEREAS, Nestlé S.A. has assigned all of its rights and obligations under the Asset Purchase Agreement to Galderma; and

WHEREAS, this Assignment is being entered into in connection with the Closing of the Purchase Agreement.

NOW, THEREFORE, for good and valuable consideration, including the premises and covenants set forth in the Purchase Agreement, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Capitalized terms not otherwise defined herein have their respective meanings set forth in the Purchase Agreement.
2. Effective as of the Closing, subject to the terms and limitations set forth in the Purchase Agreement, each Assignor hereby sells, conveys, assigns, transfers and delivers to Assignee, and Assignee hereby purchases and accepts from each Assignor, all of such Assignor’s right, title and interest throughout the world in and to the Acquired Intellectual Property Rights, including, without limitation, the Scheduled Intellectual Property Rights, together with all international, regional, federal, state, local, statutory and common law and other rights therein and the goodwill connected with the use thereof and symbolized thereby, including, without limitation, all rights to (i) enforce, and bring actions for all past, present and future infringement or violation of the Acquired Intellectual Property Rights, seek damages, profits, injunctive relief, costs, and other remedies on account thereof, and to settle, and collect and retain the proceeds therefrom, (ii) collect royalties and other payments under or on account of any of the Acquired Intellectual Property Rights, and (iii) apply for, file, register, maintain, extend, or renew same,

and seek protection therefor, with full benefit of such priority as may now or hereafter be granted to it by Law, treaty or other international convention; and to transfer same and grant licenses and other rights with respect thereto.

3. Each Assignor and Assignee hereby agree to execute such other documents (including any documents required to record the assignments effected herein with the Intellectual Property registries in the jurisdictions in which any Acquired Intellectual Property Rights are registered) and perform such further acts as may be reasonably required or advisable to carry out or confirm the provisions hereof and the transactions contemplated hereby.

4. The Assignors and Galderma acknowledge that Schedule 1.1(b) of the Seller Disclosure Letter mistakenly includes and omits certain Intellectual Property, and thus, the Assignors and Galderma hereby agree that the attached Schedule A replaces and supersedes in its entirety Schedule 1.1(b) of the Seller Disclosure Letter, effective as of the date of the Purchase Agreement.

5. Except as set forth in Section 4, (i) nothing in this Assignment, express or implied, is intended to or shall be construed to modify, expand, supersede or limit in any way the terms, conditions or obligations set forth in the Purchase Agreement, and (ii) to the extent that any provision of this Assignment conflicts or is inconsistent with the terms of the Purchase Agreement, the Purchase Agreement shall control and govern. For the avoidance of doubt, any controversy or claim arising under this Assignment shall be governed solely by, and subject to the terms of, the Purchase Agreement.

6. This Assignment and all actions confirmed hereby shall be governed, construed and interpreted in accordance with the terms and conditions of the Purchase Agreement and the laws of the State of New York, without giving effect to choice of law rules.

7. This Assignment may be executed in one or more counterparts, each of which shall be deemed to be an original, and all of which together shall constitute one and the same instrument.




