**CERTIFICATE OF MERGER  
OF  
AGERO MERGER CORPORATION,  
MARKERLAB LLC,  
AND  
MBSi CAPITAL CORP., INC.**

The undersigned hereby certifies as follows:

1. The constituent entities to the merger hereby effected are Agero Merger Corporation, a Delaware corporation ("**Merger Sub**"), MarkerLab LLC, a Delaware limited liability company ("**MarkerLab**"), and MBSi Capital Corp., Inc., a Nevada corporation ("**MBSi**").
2. An Agreement and Plan of Merger (the "**Merger Agreement**") dated as of August 29, 2014, by and among Merger Sub, MarkerLab, and MBSi, and certain others, has been approved, adopted, certified, executed, and acknowledged by each of Merger Sub, MarkerLab, and MBSi in accordance with Section 252 of the Delaware General Corporation Law and Title 6, Section 18-209 of the Delaware Limited Liability Company Act.
3. Each of Merger Sub and MarkerLab will be merged with and into MBSi. MBSi will be the surviving foreign corporation in the merger hereby effected, and its name will change to MBSi Corp.
4. At the effective time of the Merger, the certificate of incorporation of the surviving foreign corporation, as amended and restated, will be its certificate of incorporation.
5. The executed Merger Agreement is on file at an office of the surviving foreign corporation having an address c/o Agero, Inc., One Cabot Road, Medford, Massachusetts 02155.
6. A copy of the Merger Agreement will be furnished by the surviving foreign corporation, on request and without cost, to any stockholder of any constituent corporation, or to any member of MarkerLab or any person holding an interest in MarkerLab.
7. The surviving foreign corporation agrees that it may be served with process in the State of Delaware in any action, suit, or proceeding for enforcement of any obligation of MarkerLab, Merger Sub, or of the surviving foreign corporation arising from this merger, including any suit or other proceeding to enforce the rights of any stockholders as determined in appraisal

proceedings pursuant to the provisions of Section 262 of the Delaware General Corporation laws, and irrevocably appoints the Secretary of State of Delaware as its agent to accept services of process in any such suit or proceeding. The Secretary of State of Delaware will mail any such process to the surviving foreign corporation at c/o Agero, Inc., One Cabot Road, Medford, Massachusetts 02155.

8. This Certificate of Merger and the merger hereby effected will be effective under Delaware law upon the close of business of the date of the filing with the Secretary of State of the State of Delaware.
