INTELLECTUAL PROPERTY ASSIGNMENT

THIS INTELLECTUAL PROPERTY ASSIGNMENT (the "Assignment") is made as of this 21st day of November, 2014 by and between **BuildingBlok LLC**, a Delaware limited liability company ("Assignor"), and **Contractors Register, Inc.**, a New York corporation ("Assignee").

WHEREAS, Assignor desires to irrevocably grant, transfer and assign to Assignee, and Assignee desires to accept the grant, transfer and assignment of, any and all Purchased Assets which are Intellectual Property and/or intangible assets, including without limitation those assets listed on Exhibit A attached hereto (collectively, "Intangibles").

NOW, THEREFORE, for and in consideration of the mutual covenants contained herein and other good and valuable consideration, the sufficiency of which is hereby acknowledged:

1. Effective as of the Effective Time, Assignor hereby irrevocably sells, conveys, assigns, transfers and delivers to Assignee, and Assignee hereby purchases, acquires and accepts the grant, transfer and assignment of, all of Assignor's worldwide right, title and interest in, to and under the Intangibles, the same to be held and enjoyed by the said Assignee, its successors and assigns from and after the date hereof as fully and entirely as the same would have been held and enjoyed by the said Assignor had this assignment not been made.

2. Assignor agrees to execute any and all applications, assignments or other instruments which Assignee deems desirable or necessary to protect Assignee's interests in the Intangibles.

3. From and after the date hereof, but subject to the terms and conditions hereof, Assignor and Assignee shall do such acts and execute such documents and instruments as may be reasonably required to make effective the transactions contemplated hereby.

4. Assignor hereby authorizes all appropriate governmental entities to record this Assignment, and to issue or transfer all said Intangibles to Assignee as owner of all right, title and interest therein, or otherwise as Assignee may direct, in accordance with the terms of this Assignment.

5. Except to the extent that federal law preempts state law with respect to the matters covered hereby, this Assignment shall be governed by and construed in accordance with the laws of the State of New York, without regard to its conflicts of law principles.

6. Capitalized terms used but not defined herein shall have the meanings ascribed to such terms in the Asset Purchase Agreement dated as of November 11, 2014 by and between Assignor and Assignee.
