**NOTICE OF RELEASE
OF TRADEMARK COLLATERAL AGREEMENT**

This **NOTICE OF RELEASE OF TRADEMARK COLLATERAL AGREEMENT** ("Notice of Release"), dated as of 2015, is made by **BANK OF AMERICA, N.A.**, in its capacity as Administrative Agent (the "Administrative Agent").

WHEREAS, GOLD COAST BEVERAGE DISTRIBUTORS, INC. ("Grantor") and SUNTRUST BANK, as Administrative Agent ("SunTrust") entered into that certain Trademark Collateral Agreement ("Trademark Collateral Agreement") dated as of July 22, 2011, which was recorded in the records of the Trademark Assignment Division of the U.S. Patent and Trademark Office on October 25, 2011 at Reel 004648, Frame 0053, whereby Grantor granted to SunTrust a continuing security interest in all of its right, title and interest in all Intellectual Property, including, without limitation, each trademark registration and application listed below (the "Trademarks"):

WHEREAS, SunTrust assigned all of its rights and obligations under the Trademark Collateral Agreement to the Administrative Agent evidenced by that certain Notice of Assignment of Trademark Collateral Agreement ("Assignment") between SunTrust and the Administrative Agent dated as of April 9, 2013, which was recorded in the records of the Trademark Assignment Division of the U.S. Patent and Trademark Office on April 16, 2013 at Reel 005007, Frame 0539.

WHEREAS, the Administrative Agent has agreed to release its security interest in, and discharge fully its lien on, the Trademarks in accordance with the terms of the Trademark Collateral Agreement and Assignment, and as herein provided.

NOW, THEREFORE, pursuant to the Trademark Collateral Agreement and Assignment, and upon the terms set forth in this Notice of Release, the Administrative Agent hereby agrees as follows:

1. Release of Security Interest. For valuable consideration, the Administrative Agent hereby terminates, discharges and releases all mortgages, liens and security interest granted to the Administrative Agent in the Trademarks without representation, warranty or recourse of any kind, and any right, title or interest of the Administrative Agent in such Trademarks shall hereby cease and become void.
